# CONTRACT OF AGREEMENT

## KNOW ALL MEN BY THESE PRESENT:

The PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES (PCAF), a government agency attached to the Department of Agriculture (DA), created pursuant to Executive Order No. 366, Series of 2004, and the Department of Budget and Management (DBM) approved Rationalization Plan covering the consolidation of the National Agricultural and Fishery Council (NAFC) and Livestock Development Council (LDC) on June 26, 2013, with office address at the Apacible Hall, Department of Agriculture Compound, Elliptical Road, Diliman, Quezon City, represented in this Act by its OIC-Executive Director, JULIETA E. OPULENCIA, hereinafter referred to as the PCAF;

-and-

MINDANAO AVENUE SERVICENTER, a company licensed to operate business under the laws of the Republic of the Philippines with principal office address at 57 Mindanao Avenue, Brgy. Pagasa, Quezon City, represented in this Act by its Authorized Representative, LIBORIO PANGAN, hereinafter referred to as the SUPPLIER.

#### WITNESSETH

**WHEREAS, the PCAF** requested the procurement of one (1) lot procurement of diesel fuel, change oil and other related products/services for the period January 2, 2024 to December 31, 2024 through PR No. 24-01-005 and was posted in the PhilGEPS for bidding;

**WHEREAS,** the **SUPPLIER** is engaged in the supply of diesel fuel, change oil and other related products/services and had submitted its quotation;

**WHEREAS,** after due evaluation by the Bids and Awards Committee (BAC), the **SUPPLIER** was declared as the Lowest Calculated and Responsive Bid, thus, the BAC recommended to the HOPE to award the above mentioned procurement to the **SUPPLIER**;

WHEREAS, PCAF issued the Notice of Award to the SUPPLIER on January 16, 2024;

**NOW THEREFORE,** in view of the foregoing premises, the parties have agreed to these following terms and conditions:

### A. OBLIGATIONS OF PCAF

1. Allocate and disburse funds in the total amount of **Seven Hundred Twenty-Nine Thousand Three Hundred Pesos (Php 729,300.00)** to **MINDANAO AVENUE SERVICENTER** for the procurement of one (1) lot procurement of diesel fuel, change oil and other related products/services for the period January 2, 2024 to December 31, 2024;

- 2. Process the payment in accordance with the applicable existing accounting and auditing rules and regulations; and
- 3. Pay the **SUPPLIER** on a monthly basis upon receipt of billing statements with complete supporting documents based on the fuel price withdrawn for the day.

### B. OBLIGATIONS OF THE SUPPLIER

1. Provide the required one (1) lot procurement of diesel fuel, change oil and other related products/services for the period January 2, 2024 to December 31, 2024 in the total amount of **Seven Hundred Twenty-Nine Thousand Three Hundred Pesos (Php 729,300.00)** as follows:
