We would like to endorse the findings and validations made by the BAC Technical Working Group (TWG) on the authenticity of documents submitted by the bidders relative to the procurement of One (1) Lot Seven (7) Units Laptop, Seven (7) Units Desktop, Fourteen (14) Units Licenses of Antivirus, and Fourteen (14) Units of Office Productivity Software with Purchase Request No. No. 24-03-114:

- Upon review of the documents furnished by the BAC Secretariat, it was established that there is only one (1) bidder, and the Approved Budget for the Contract (ABC) is One Million One Hundred Forty Eight Thousand Only (Php 1,148,000.00).
- The lone bidder is Terabit Computer Systems Corporation with a bid of Nine Hundred Forty-Six Thousand Seven Hundred Fifty Pesos Only (Php 946,750.00).
- 3. On May 8, 2024, an ocular inspection was conducted by the Bids and Awards Committee Technical Working Group for ICT-Related Equipment and Services at Terabit Computer Systems Corporation at 20F Cityland Pasong Tamo Tower, Chino Roces Avenue, Makati City, Metro Manila, NCR, Philippines. The activity was assisted by Mr. Kristian Martin Santiago, Sales Associate. The primary objective of the activity was to assess the capacity of Terabit Computer Systems Corporation to provide the procurement requirements and validate the authenticity of the documents submitted against the original copies.
- 4. The documents submitted, as enumerated in the Checklist of Requirements were verified against the original copies. Based on our evaluation, the documents submitted are in accordance with the requirements as they are true and faithful copies of the original documents presented during the conduct of the post qualification.
