OPULENCIA, hereinafter referred to as the PCAF;

CONTRACT PRICE

- 3. Hold **PCAF** free from any third-party liability arising from damages to public and private properties, death, or injury to people as a result of any incident attributed to the **SUPPLIER's** fault that may have occurred during the performance of the contract.
- 4. Ensure that all the services to be performed under or pursuant to this contract shall meet the same high standards as those offered by similar businesses of superior knowledge and skill, engaged in similar services under analogous circumstances;
- 5. Issue an Official Receipt in the name of PCAF upon receipt of full payment.
- 6. Book **PCA** for a different date if the event is canceled due to unforeseen circumstances. The new schedule will be mutually agreed upon by both parties.

The PCAF shall:

A. OBLIGATIONS OF PCAF

- 1. Ensure that the **SUPPLIER** meets the required specifications on the day of the activity;
- 2. Pay the **SUPPLIER** the guaranteed number of participants after completion of the activity and receipt of the billing statement;
- 3. Agree that it shall be charged or billed the total amount of TWO MILLION THREE HUNDRED FORTY THOUSAND PESOS (Php2,340,000.00) inclusive of government taxes for the whole duration of the event; and
- 4. Exercise strict discipline and ensure that personnel are closely supervised and managed in accordance with the law and policies set forth by the **SUPPLIER**.

Section 5

TERMS OF PAYMENT

The total contract price for the accommodation services is **TWO MILLION THREE HUNDRED FORTY THOUSAND PESOS (Php 2,340,000.00)** inclusive of all applicable government taxes and fees for the whole duration of the event.

In accordance with Section 4.3 of Annex "D" of 2016 Revised IRR of RA 9184, which allows a single advance payment not exceeding fifty percent (50%) of the contract amount for hotel and restaurant services where down payment is a standard industry practice, PCAF binds itself to pay the SUPPLIER 50% of the total contract price as an advance payment, amounting to ONE MILLION ONE HUNDRED SEVENTY THOUSAND PESOS (Php 1,170,000.00), upon the perfection of the contract and the signing of the Notice to Proceed by the SUPPLIER.

The remaining 50% of the total contract price, amounting to **ONE MILLION ONE HUNDRED SEVENTY THOUSAND PESOS (Php 1,170,000.00)**, shall be paid within thirty (30) days after the conclusion of the 2024 National Agri-Fishery Volunteers' Day and upon receipt of the billing statement.
