OPULENCIA, hereinafter referred to as the PCAF;

#### WITNESSETH

WHEREAS, PCAF requested the procurement of one (1) lot "MEALS AND ACCOMODATION FOR THE CONDUCT OF PMT EXIT CONFERENCE OF SOCCSKSARGEN REGION IN GENERAL SANTOS CITY, SOUTH COTABATO" on September 12-13, 2024 with approved Purchase Request No. 24-07-304 and was sent through email to at least three (3) prospective bidders;

WHEREAS, the SUPPLIER has represented and warranted itself as capable, competent and duly licensed provider of meals and accommodation services under the terms and conditions hereinafter set forth;

WHEREAS, the Approved Budget for the Contract is ONE HUNDRED TEN THOUSAND PESOS ONLY (Php 110,000.00);

WHEREAS, PCAF has agreed to enter into a contract with the SUPPLIER for the engagement of its services through Negotiated Procurement - Lease of Venue as an alternative mode of procurement pursuant to Section 48 of the revised implementing Rules and Regulations of the Republic Act No. 9184;

WHEREAS, the opening of bid was undertaken on July 15, 2024, and after due evaluation by the Bids and Awards Committee (BAC), the **SUPPLIER** was declared as the Lowest Calculated and Responsive Quotation, thus, the BAC recommended to the HOPE to award the above-mentioned procurement to the **SUPPLIER**;

WHEREAS, PCAF issued the Notice of Award No. 2024-105 to the SUPPLIER on July 15, 2024;

NOW THEREFORE, in view of the foregoing premises, the parties have agreed to the following terms and conditions:

Section 1

## RESPONSIBILITIES OF THE SUPPLIER

The SUPPLIER shall:

1. Provide the required food and venue on September 12-13, 2024 to the FIFTY (50) participants, of PCAF;

# RESPONSIBILITIES OF PCAF

# The PCAF shall:

1. Pay the **SUPPLIER** the guaranteed number of participants after completion of the activity and receipt of the billing statement;

2. Agree that it shall be charged or billed the total amount of **ONE HUNDRED TEN THOUSAND PESOS ONLY (Php 110,000.00) inclusive of government taxes,** for the whole duration of the event;

3. Exercise strict discipline and ensure that personnel are closely supervised and managed in accordance with law and policies set forth by the **SUPPLIER**.

### Section 3

#### TERMS OF PAYMENT

**PCAF** binds itself to pay the **SUPPLIER** within thirty (30) days after the conclusion of the training / seminar/ activity and upon the receipt of the billing statement.

#### Section 4

#### INCLUSION IN THE SERVICES

The SUPPLIER shall provide for the following:

## a. Food/Meals

2. Day 2 - Buffet Breakfast, AM Snacks, Managed Buffet Lunch, PM Snacks

- c. At least two (2) whiteboards with markers, eraser, pads, and pen
- 4. Complimentary Wi-Fi connectivity to all rooms and conference room;
- 5. Flowing coffee/tea and purified water, candies/mints, and peanuts during sessions.

In case of litigation arising from or in connection with this contract, the parties agree that the venue of action shall be at the proper court in Quezon City only to the exclusion of other courts.

Each party in this contract assures and warrants that it has the authority to sign and fulfill the agreement without violating any laws or existing agreements. Additionally, it confirms that the contract is legally binding and enforceable.

LIQUIDATED DAMAGES

As provided in Section 68 of the revised IRR of RA 9184, the winning bidder shall pay liquidated damages in case of breach of contract. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.
