	Reply: Yes, the members of the BAC have agreed, and they will proceed by issuing a bid supplemental document regarding this matter.	
	2. He asked whether it is necessary to strictly adhere to the dimensions and weight of the airconditioning units specified in the technical specifications, as they are concerned that the newer models of airconditioning units may be smaller than what is specified.	
	Reply: The BAC will coordinate with the end user regarding these specifications and will make any necessary revisions to ensure that the specifications accurately reflect the actual items to be procured.	
	Mr. Manio stated that he will submit more detailed clarifications regarding the technical specifications of the air conditioning units.	
	The deadline for the clarification on and/or interpretation of any part of the bidding documents is on November 30, 2024.
