

CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Contract of Agreement made and entered into this _____ day of _____ 2024 at Quezon City, Philippines, by and between:

The **PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES (PCAF)**, a government agency attached to the Department of Agriculture (DA), created pursuant to Executive Order No. 366, Series of 2004, with office address at the Apacible Hall, Department of Agriculture Compound, Elliptical Road, Diliman, Quezon City, represented in this Act by its OIC - Executive Director, **JULIETA E. OPULENCIA**, hereinafter referred to as the **PCAF**;

-and-

TOYOTA QUEZON AVENUE, INC., a registered corporation duly organized under Philippine laws and licensed to operate business in the Philippines, with principal office address at 728 Quezon Avenue, Quezon City, represented in this Act by its duly authorized representative, **ROSALYN LANDICHO**, Authorized Dealer Representative, hereinafter referred to as the **SUPPLIER**.

WHEREAS, the **PCAF** invited Bids for certain goods and ancillary services, particularly for the **Procurement of one (1) Lot Supply and Delivery of two (2) Units Passenger/Commuter Vans** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **FOUR MILLION ONE HUNDRED SIXTY THOUSAND PESOS (Php 4,160,000.00)** (hereinafter called "the Contract Price").

WITNESSETH

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;


- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **FOUR MILLION ONE HUNDRED SIXTY THOUSAND PESOS (Php 4,160,000.00)**, **TOYOTA QUEZON AVENUE, INC.** agrees the **Supply and Delivery of Two (2) Units Passenger/Commuter Vans** in accordance with its Bid.
 4. The **PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES** agrees to pay the above-mentioned sum in accordance with the terms of the bidding.


