II. Topics Discussed

A. Submission of the Bidding Documents

B. Checking the Technical and Financial Documents Copy Data System Corporation (Copy Data), Philcopy Corporation (Philcopy) and ECopy Corporation (ECopy) submitted bids for the Procurement of One (1) Lot Five (5) Units High-Quality Multifunction Network Printers and One (1) Unit Digital LED Printer. All bidders submitted one (1) original copy and two (2) photocopies of the bids through the BAC Secretariat before the set deadline.

The BAC, together with the BAC TWG-ICTS, conducted the opening of bids for the procurement of one (1) lot of five (5) units of high-quality multifunction network printers and one (1) unit of digital LED printers.

The following bidders submitted their bids:

The BAC opened the bidders' submitted bids and found the legal/technical and financial documents in order.

Using a non-discretionary "pass/fail" criterion and guided by a checklist, all the required documents are present in the submitted legal/technical and financial bids.

However, the submitted *Notarized Bid Securing Declaration and Omnibus Sworn Statement* of the **Ecopy** are unsigned; therefore, the BAC rated it as "failed."

While the submitted "Statement of the prospective bidder of all its ongoing government and private contracts" of the Copy Data did not mention the "status" of their ongoing private contracts; therefore, the BAC rated it as "failed."

Mr. Dumalagan from Copy Data informed the body of their intention to file a motion for reconsideration on the matter.

For the Philcopy, the BAC rated the submitted bids as "passed" (see attached checklist accomplished by the BAC members).

	After determining compliance with technical and financial requirements, the bid procedure continued to open the second envelope of Philcopy containing the suppliers' financial offering. Below is the financial bid of Philcopy:
