The PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES (PCAF), agency attached to the Department of Agriculture (DA), created pursuant to Executive Order No. 366, Series of 2004, with office address at the Apacible Hall, Department of Agriculture Compound, Elliptical Road, Diliman, Quezon City, represented in this Act Executive Director, JULIETA E. OPULENCIA, hereinafter referred to as the PCAF;

-and-

a registered corporation duly organized under GOLDEN PRINCE HOTEL AND SUITES, with principal office Philippine laws and licensed to operate business in the Philippines, address at Acacia St. Cor Archbishop Reyes Ave, Kamputhaw, Cebu City, represented in this Act by its duly authorized representative, Sales Account Manager, MS. ODETTE ROSELL, hereinafter referred to as the SUPPLIER.

WITNESSETH

WHEREAS, PCAF requested the procurement of one (1) lot food and accommodation for the Conduct of FY 2024 Visayas Participatory Performance Review and Planning Workshop cum PL480 Performance Assessment on September 30 - October 4, 2024 in Cebu City with approved PR No. 24-09-412 and Request for Quotation was emailed to three (3) prospective suppliers/contractors with known qualifications.

WHEREAS, the SUPPLIER has represented and warranted itself as capable, competent and duly licensed provider of meals and accommodation services under the terms and conditions hereinafter set forth;

WHEREAS, PCAF has agreed to enter into a contract with the SUPPLIER for the engagement of its services through Negotiated Procurement under Lease of Venue as an alternative mode of procurement pursuant to Section 53.10 of the 2016 Revised Implementing Rules and Regulations of the Republic Act No. 9184;

WHEREAS, the opening of bid was undertaken on September 16, 2024, and after due evaluation by the Bids and Awards Committee (BAC), the SUPPLIER was declared as the Single Calculated and Responsive Quotation, thus, the BAC recommended to the HOPE to award the above-mentioned procurement to the SUPPLIER;

WHEREAS, PCAF issued the Notice of Award to the SUPPLIER on September 16, 2024;

the foregoing premises, the parties have agreed to the NOW THEREFORE, in view of following terms and conditions:



SCOPE OF SERVICES

The **SUPPLIER** will provide food, accommodation, and venue for a total of **ONE HUNDRED THIRTY FIVE (135) participants** during the FY 2024 Visayas Participatory Performance Review and Planning Workshop, including the PL480 Performance Assessment, scheduled from September 30 to October 4, 2024.

Section 2

CONTRACT PRICE

For and consideration of the SERVICES to be undertaken by the **SUPPLIER**, **PCAF** shall pay the **SUPPLIER** in Philippine Currency in accordance with the Contract the total amount of **EIGHT HUNDRED NINETY-THREE THOUSAND FIVE HUNDRED PESOS ONLY** (Php 893,500.00) inclusive of all applicable government taxes and fees for the whole duration of the event.

Section 3

RESPONSIBILITIES OF THE SUPPLIER

The SUPPLIER shall:

- 1. Provide the necessary food, accommodation, and venue for a total of **ONE HUNDRED THIRTY FIVE (135)**participants during the FY 2024 Visayas Participatory

 Performance Review and Planning Workshop, including the PL480 Performance

 Assessment, scheduled from September 30 to October 4, 2024;
- 2. Be held accountable for all liabilities resulting from damage to properties and lives attributed to the **SUPPLIER's** fault or negligence for the duration of this contract;
- 3. Hold **PCAF** free from any third-party liability arising from damages to public and private properties, death, or injury to people as a result of any incident attributed to the **SUPPLIER's** fault that may have occurred during the performance of the contract;
- 4. Ensure that all the services to be performed under or pursuant to this contract shall meet the same high standards as those offered by similar businesses of superior knowledge and skill, engaged in similar services under analogous circumstances;
- 5. Issue an Official Receipt in the name of PCAF upon receipt of full payment;
- 6. Book **PCAF** for a different date at no additional cost if the event is canceled due to unforeseen circumstances. The new schedule will be mutually agreed upon by both parties.



TERMINATION OF CONTRACT

PCAF reserves the right to terminate this Contract for any substantial breach committed by the **SUPPLIER** and such breach is not corrected within a reasonable time upon demand, as warranted by the circumstances.

VENUE OF ACTION

The parties shall make every effort to resolve amicably and by mutual consultation any or all disputes or differences arising between the Parties in connection with the implementation of this Contract. In case of litigation arising from or in connection with this contract, the parties agree that the venue of action shall be at the proper court in Quezon City only to the exclusion of other courts.

Section 10

CAPACITY AND AUTHORIZATION

Each party in this contract assures and warrants that it has the authority to sign and fulfill the agreement without violating any laws or existing agreements. Additionally, it confirms that the contract is legally binding and enforceable.

Section 11

LIQUIDATED DAMAGES

As provided in Section 68 of the revised IRR of RA 9184, the winning bidder shall pay liquidated damages in case of breach of contract. The amount of liquidated damages shall be at least equal to one-tenth of one percent (0.001) of the cost of the unperformed portion for every day of delay. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.

Section 12

OTHER CONDITIONS OF THE CONTRACT

In case of damage or loss to the property of the participants of **PCAF** caused by negligence of the **SUPPLIER**'s personnel or employee, the **SUPPLIER** shall be liable for the damages;

Necessary medical services and facilities shall be the responsibility and for the account of the **SUPPLIER**; and

The **SUPPLIER** shall exercise extraordinary difigence in the performance of its duties. Additionally, all services rendered under or pursuant to this contract shall adhere to the same high standards as those offered by comparable businesses with superior knowledge and skill operating under similar circumstances.



RESPONSIBILITIES OF PCAF

The PCAF shall:

- 1. Ensure that the SUPPLIER meets the required specifications on the day of the activity.
- 2. Pay the SUPPLIER the guaranteed number of participants after completion of the activity and upon the receipt of the billing statement;
