The PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES (PCAF), a government agency attached to the Department of Agriculture (DA), created pursuant to Executive Order No. 366, Series of 2004, and the Department of Budget and Management (DBM) approved Rationalization Plan covering the consolidation of the National Agricultural and Fishery Council (NAFC) and Livestock Development Council (LDC) on June 26, 2013, with office address at the Apacible Hall, Department of Agriculture Compound, Elliptical Road, Diliman, Quezon City, represented in this Act by its OIC Executive Director, JULIETA E. OPULENCIA, hereinafter referred to as the PCAF;

HARBOR LIGHTS HOTEL & RESTAURANT, INC., a company licensed to operate business under the laws of the Republic of the Philippines with principal office address at Old Rosa Gusa, Cagayan de Oro City, represented in this Act by its Authorized Representative, LUCENA YBAÑEZ, hereinafter referred to as the SUPPLIER.

## WITNESSETH

# A. OBLIGATIONS OF PCAF

- Allocate and disburse funds in the total amount of Four Hundred Twenty Six Thousand Six Hundred Pesos (Php 426,600.00) to HARBOR LIGHTS HOTEL & RESTAURANT, INC. for the procurement of One (1) Lot Meals and Accommodation (Full Board) with Free Hotel Transport for the conduct of the seminar-workshop cum practicum in Cagayan De Oro City; and
- 2. Pay the SUPPLIER after completion of the activity and receipt of the billing statement.
